

Public meeting slams Shearwater development

IN A public meeting held last night by Shearwater's Save Our Seaside Village group, a crowd of over 200 overwhelmingly voted to support a motion of no confidence in the Latrobe Council.

The motion will today be sent to members of state and federal parliament, demanding a public inquiry into the new commercial development, a new town centre including a major supermarket and other shops, planned 700 metres from the existing town centre.

A mere six or so hands were raised in opposition to the motion; a number dwarfed by the 200-odd hands raised in support of it.

At the meeting, which took place at the Shearwater Country Club Resort, concerned locals wanted questions answered; they wanted an assurance that the 250-square metre prohibition policy would be looked at in July by the council, they wanted evidence of any previous public notices calling for expressions of concern, they wanted answers.

Nicholas Dodd, of the Shearwater Country Club Resort, spoke on behalf of the 2300 guests who partown the resort through a time-share arrangement.

"I've been investing in infrastructure over the past few years . . . This would seriously jeopardise any further investment on my behalf that would benefit the community," Mr Dodd said


"And if I lose 50 per cent of my bottleshop revenue, which would happen once a larger competitor moved in, I'll be forced to restructure my business and shuffle workers — I don't want to do that," he said.

Shearwater Newsagent owner Emma Glover, said over time her business had donated a large number of profits to local causes.

"Tm just wondering, if Woolies move in, will they do the same?" she asked of the Latrobe councillors present.

"And how could the current population possibly be able to sustain two supermarkets, three bottleshops and two bakeries?"

Anne Lockett, a Hawley Beach resident, made reference to the damage being inflicted by gross supermarket branding on

the local farming industry.

"We don't want to have the spin-offs off more big chain stores — we can already see how that is destroying our farming trade!" she pointed out.

In a display of transparency, Latrobe Mayor Mike Gaffney and Latrobe Council general manager Gerald Monson led the audience through the chronological history of the Alexander Street planning development.

Mr Monson pointed out that the proposed development area was zoned as commercial as early as 2006.

He also pointed out that the sale of that land to Fairbrother Construction was approved by council as early as 2007; not a mere six

said.

Mr Gaffney said he was disappointed to see the words "un-Australian", "cruel hoax", "repeatedly refused" and "unjust" slashed over the pamphlet advertising the public meeting.

"I don't believe these reflect the content of discussions the council has already held with the SOSV group. We have always been prepared to sit down, hear your views, and respond openly and honestly," he said.

He said he believed taking the parliamentary route would not be fruitful to the cause and would only add to negative publicity and widespread media speculation.

"You can't just wake up one day and change a planning scheme. We are a planning authority and here we have a commercial zone and a company that has spent thousands already on that project under the rightful assumption it is theirs. We are not legally able to turn around and say, 'stop'. What will Fairbrother do? They will hire the most expensive lawyer possible and take us to court costing ratepayers more than they could imagine. We are not prepared to do that - we can't do that," Mr Gaffney said.
